SLPOA Update

ost of you are aware of the horrific events in Feguson resulting in a serious injury to Officer Travis Brown. The latest update on his condition is not encouraging but he continues to fight for his life, and we hope and pray that he makes a full recovery. The SLPOA Executive Board made an immediate contribution to his family to help with expenses and a Go Fund Me account has also been established. Please keep Officers Brown and his family in your thoughts and prayers.

Labor Update

SLPOA has restarted wage negotiations with the City and the Police Department as outlined in our current agreement. The labor committee is working to increase salaries for Police Officers and Sergeants which will ultimately affect all ranks throughout the department. Negotiations are confidential and it would not be proper for us to discuss details away from the table. We do not want to jeopardize good faith or the confidentiality of the process. However, in the interest in keeping our membership informed, we do want to share some basic information about our committee's position.

I'm sure most of you are aware by now that the Department is looking to move to a modified work schedule to help address the staffing shortages. All the labor groups and other department representatives have been meeting with the Chief's office to discuss these plans. The intention is to add more officers on the street by moving to an eleven- or twelve-hour day or something similar.

eleven- or twelve-hour day or something similar. Most departments throughout the area are already in some variation of a ten-, eleven- or twelve-hour day. That being said, hours of work are a mandatory subject of bargaining and will only be settled and agreed to through the bargaining process.

This manpower shortage isn't exclusive to St. Louis City or to SLMPD. We are seeing the result of years of negative rhetoric against and about police officers and the policing profession which has led to mass early retirements and a disinterest in the policing profession as a whole. Despite the department's recent efforts, they are still struggling to recruit and retain officers, as are most departments throughout the area. The struggle to entice police officers is challenging but the best way to attract new officers and retain the ones you have is through competitive salaries. Let's put that in perspective.

The SLPOA recently received a pay comparison study conducted by the St. Louis Area Police Chiefs Association which demonstrated the low rankings of St. Louis City officers' pay. St. Louis City officers' pay ranked thirty-three out of thirty-five departments in starting salary for officers, thirty-one out of thirty-five in top salary and dead last in the number of years it takes to reach your top salary at a whopping thirty-year mark. That is fifteen years longer than our closest competitor, St. Louis County Police, at fifteen years. The average number of years for area officers to

reach their top salary is just over nine years. The results showed City officers' starting pay is over \$10,000 less than the area average and our top pay is \$7,000 lower than the top average salary.

St. Louis City Police Sergeants weren't much better. Sergeants ranked twenty-nine in starting salary and twenty-nine in top salary. They were also dead last in the number of years it takes to reach the top salary at twenty-five years. St. Louis City Sergeants starting pay is more than \$9,000 lower than the area average and their top pay is nearly \$10,000 lower than the area average. The average number of years it takes for St. Louis area sergeants to reach their top pay is just under eight years. It takes SLMPD sergeants seventeen years longer to reach their top salary when compared to that average and twelve years longer than our closest competitor, Overland PD, who tops out after thirteen years.

The moral of this story is despite a genuine effort by the City and Police Leadership to increase salaries last year (8%, 10%, 12% respectively for officers and 9%, 11%, and 13% for sergeants) we are still lagging far behind our counterparts in the St. Louis area. Once our salaries went up, so did salaries for everyone else.

This data was shared with the Police Leadership, the Mayor's office and with the St. Louis City office of the Director of Personnel. The Police Department budget has already been passed by the Board or Alderman so any raises would have to come from within that budget. With our

Thank you for answering the call to get out the vote! Your concerted action and encouragement of others to get out and vote was invaluable to the mission of SLPOA and the future of the entire state of Missouri. Your involvement shows that we can make a difference when we individually and collectively act. The elections on Tuesday now set the stage for the Nov. 5 general election and beyond.

PRIMARY ELECTION RESULTS

The 2024 Missouri primaries were some of the most hard-fought and unpredictable in recent history. These results will have a major impact on the political landscape in the state going forward. We don't want to downplay the importance of voting in the November general election as it will be equally important to get our endorsed candidates across the finish line. Because Missouri is such a Republican leaning state, Tuesday's primary election was a huge piece of the puzzle in setting the stage for who will be serving during the 2025 legislative session.

In the general election this November, only 2 out of the 17 State Senate seats and less than 5 out of 163 total House districts will likely be competitive. Below is a recap of some of the more notable races.

STATEWIDE RESULTS:

Lt Gov Mike Kehoe Wins the Republican Primary for Governor!

FOP/SLPOA endorsed gubernatorial candidate, Lt. Governor Mike Kehoe, won with 39.41% of the vote, defeating two strong challengers Sen. Bill Eigel (32.55%) and Secretary of State Jay Ashcroft (23.24%). Kehoe now faces Democrat Rep. Crystal Quade from Springfield in the November general election. We have poured more resources and effort into Mike Kehoe than any other endorsed candidate in the history of the FOP and we are certain that he will win in November.

Lieutenant Governor:

David Wassinger won the Republican primary for Lt. Governor.



Cash or Checks accepted

Wassinger (31.28%) narrowly defeated Senator Lincoln Hough (30.25%) with Senator Holly Rehder (21.66%) coming in third. Hough will return to the Senate to finish out his last 2 years. Rehder was term limited and will not return after this loss. We know little about political newcomer Wassinger. He was raised in Hannibal, Missouri, attended the University of Missouri, and received a JD from Vanderbilt University. He resides in St. Louis with his wife and two sons. He will face Democrat Rep. Richard Brown from Kansas City in November.

Attorney General:

Incumbent Andrew Bailey held off the challenge from well-funded Will Scharf (63.01% - 36.98%). In November we expect Bailey is likely to be elected to a full term as the Attorney General. Bailey was appointed by the Governor to be the Attorney General when US Senator Eric Schmitt vacated the seat position after winning his current office.

Andrew Bailey has been a staunch supporter of law enforcement from day one and without him, it is a real likelihood that we would still have Kim Gardner in office. Bailey will face Democrat Elad Gross and Libertarian Ryan L. Munro in November.

State Treasurer Race:

Vivek Malek defeated two current members of the General Assembly, Rep Cody Smith from Joplin and Senator Andrew Koenig from west St. Louis County. Neither legislator will continue in their current roles as legislators after their term expires in December. Malek, like AG Bailey, was appointed by the Governor when current State Auditor Scott Fitzpatrick won that office in 2022. Malek will face Democrat Mark Osmack and Libertarian John A. Hartwig Jr. in November.

Secretary of State Race:

Sen. Denny Hoskins won this race with a low 24.5% of the vote. The field was so large and so competitive in this race with all 8 candidates considered viable, that an even split of voters allowed the winner to secure the Republican nomination with an unprecedented low vote percentage. Denny's challengers in the race were Shane Schoeller, Rep. Adam Schwadron, Jamie Corley, Speaker Dean Plocher, Sen. Mary Elizabeth Coleman, Valentina Gomez, and Mike Carter.

One of his challengers, Sen Mary Elizabeth Coleman, returns to the Senate where she will finish out the remainder of her term (2 more years) and is eligible to run for an additional 4-year term. Barbara Pfifer won the Democrat primary and will face Hoskins in November.

MISSOURI SENATE RESULTS:

There were several incumbent Senators who secured the primary nod with no serious primary competition. As expected, Senators Doug Beck (D - St. Louis County), Steven Roberts (D - St. Louis City), and Jason Bean (R-Bootheel) all won their primary election.

Several incumbents faced stiff primary competition. Senators Barbara Washington (D-KC), Angela Mosely (D-North St. Louis Co.), Mike Moon (R-Lawrence Co) and Rick Brattin (R-Cass Co) all survived strong opposition in the primary and all will most likely win their general election in November.

There were several open Senate seats with hotly contested primary races that will likely determine the next Senators for those Districts. The winners of those districts were:

- Mike Henderson defeated Rep. Cyndi Buchheit-Courtway in the 3rd
 - Patty Lewis defeated Pat Contreras in the 7th
 - Joe Nikola ousted Aaron McMullen in the 11th
 - David Gregory beat out Jim Bowlin and Mark Harter in the 15th
 - Kurtis Gregory took out Doug Richey in the 21st
 - Adam Schnelting won the 4-way primary in the 23rd over Phil Christofanelli, Rich Chrismer and Dan O'Connell


- Jamie Burger defeated Chris Dinkins and Jacob Turner in the 27th
- Brad Hudson prevailed over Travis Smith in the 33rd

MISSOURI HOUSE OF REPRESENTATIVES RESULTS:

All House seats were up for election. There are 163 total state house districts in Missouri. There were only a few notable primary surprise upsets of incumbent legislators. Below are some of the highlights worth mentioning in the House primary races:

- Going into the primary, Republicans held a 114-49 advantage in the state house. The primary election set up the general election landscape where the Republican party is still heavily favored to maintain control of the House.
- In the primary election, 5 Republican incumbents were defeated:
 - District 33: Incumbent Chris Sander (R) was defeated by challenger Carolyn Caton (R)
 - District 64: Incumbent Tony Lovasco (R) was defeated by challenger Deanna Self (R)
 - District 109: Incumbent Kyle Marquart (R) was defeated (in a rematch) by challenger John Simmons (R) who was unseated two years ago by Marquart
 - District 111: Incumbent Gary Bonacker (R) was defeated by challenger Cecelie Williams (R)
 - District 123: Incumbent Lisa Thomas (R) was defeated by challenger Jeff Vernetti (R)

 The urban areas have a few close races we will be watching in the November general election. Many factors could influence voter turnout, including ballot measures that could yield high Democrat turn out and a presidential race that could yield high Republican turn out making some seats ripe for possible party flips.

CONGRESSIONAL RESULTS:

US Senate:

Senate Josh Hawley is up for his first reelection to his seat. He ran unopposed in the Republican Primary. Lucas Kunce is the Democrat nominee. He defeated State Senator Karla May.

US House of Representatives:

Of the eight House seats in Missouri, there were two closely watched races. In Congressional District 1, Incumbent Rep. Cori Bush (D), lost (45.6%) to primary challenger Wesley Bell (51.1%).

In Congressional District 3, former state Senator Bob Onder (47.37%) defeated former state Senator Kurt Schaefer (37.22%). This seat was vacated by Sen. Blaine Luetkemeyer (R) who decided to retire. Schaefer was backed by Luetkemeyer and Onder was endorsed by Trump.

In the remaining six congressional seats, incumbents won their party's nomination: CD-2 Rep. Ann Wagner (R), CD-4 Mark Alford (R), CD-5 Rep. Emmanual Cleaver III (D), CD-6 Rep. Sam Graves (R), CD-7 Rep. Eric Burlison (R), and CD-8 Rep. Jason Smith ®.

RESULTS OF BALLOT INITIATIVES:

The primary saw two statewide ballot initiatives on the ballot, with one passing and one failing. Following a court ruling that previous ballot language regarding funding of the Kansas City Police was misleading, the measure was put on the ballot again and narrowly passed with a vote of 51% to 49%.

Constitutional Amendment 4 will allow the General Assembly to require that any city with a police department overseen by a state board of police commissioners allocate at least 25% of its budget to police funding. This was an all-important win for members of Lodge 99 and could eventually impact Lodge 68, should St. Louis return to a state board of police commissioners.

Finally, Constitutional Amendment 1 would have exempted childcare establishments from property taxes. This measure failed with 55% voting no and 45% voting yes.

Thank you again for making a difference in our endorsed races and remember to vote in the General Election in November. SLPOA will share additional information about our endorsements as election day nears.

Have Attack Ads Gone Too Far?

olice Chief Chris DiGiuseppi, President of the Missouri Police Chiefs' Association and founding member of the Law Enforcement Legislative Coalition joins efforts with Officer Jay Schroeder, President of the Missouri State Chapter of the Fraternal Order of Police and Joe Steiger, Business Manager of the St. Louis Police Officers' Association, to call out an attack ad which has "crossed the line."

"Our organizations recently learned of a false and incredibly disturbing Advertisement paid for by the Defend Missouri Political Action Committee in the Republican Attorney General race. The Advertisement exploits the murder of a police officer. This Ad and the statements it contain have the potential to jeopardize the prosecution of the Defendant in that case," says Steiger.

"The Ad claims that Attorney General Bailey does not support Law Enforcement and was somehow responsible for the release of this Defendant who committed the murder. THIS IS ABSOLUTELY NOT TRUE. Attorney General Bailey wasn't even with the prosecutor's office at the time when a judge granted this Defendant's bond over the state's objection. In addition to jeopardizing the prosecution, the Ad demonstrates a complete and utter disregard for the family of this murdered police officer. They have been through enough pain and trauma over the past year and shouldn't be subjected to images of their loved one's murder in the media for political gain. We need to stand up for the family of this police officer by ensuring that they can receive the justice they deserve for the murder of their loved one. These actions place politics over the murder of a police officer and that's WRONG, UNACCEPTABLE AND INEXCUSABLE," says Chief DiGiuseppi.


Officer Schroeder said on behalf of himself and over 8,000 FOP members Statewide, "We want to set the record straight and let the people of Missouri know that your Police Chiefs, Police Leaders and Police Officers stand by and support Attorney General Bailey's prosecution of the Defendant in the murder of our police officer. The fact that this PAC had to use a Sheriff who was suspended by his Agency due to an investigation by Attorney General Bailey's office to make this statement, is telling. Attorney General Bailey has supported Law Enforcement and continues to do so, contrary to this heinous Ad. Let us not forget, without the actions of Attorney General Andrew Bailey, Kim Gardner is likely still the Prosecuting Attorney in St. Louis."

We believe as Police Chiefs, Police Leaders and Police Officers that we MUST set the record straight and again call for the removal of this harmful Ad.

staffing levels at an all-time low, there is money available in the budget to make significant pay raises for our members. We are working diligently with the City's negotiating team to get this done. We are optimistic we can have something settled by the end of the first quarter and we are pushing to have it in place by October of this

The one constant roadblock to pay increases is the parity issue with the St. Louis Fire Department. We are forced to bargain for well-deserved increases in wages for our members but unjustly must simultaneously carry the burden of bargaining for another group (the fire department) which is connected to any raise we receive through a parity provision in the City Charter. I truly believe the City and the Department see the obvious pay disparity between our officers and officers throughout the area and they want to find a way to close the gap. However, the fire department parity provision continues to be an anchor to any negotiations. That being said, Firefighter parity is their issue, not ours, and they have to find a way to solve it if they want to keep from losing more numbers from the police department. Stay tuned for further updates as we move through the wage negotiation process.

Governor Bill Signing

SLPOA leadership joined the St. Louis County Police Officers' Association and other area FOP Lodges on Thursday, August 22nd for the Governor's signing of the omnibus crime bill which passed through the state legislature this past session. The bill contains many pro law enforcement provisions, most importantly Valentine's Law, which establishes mandatory jail time and expanded penalties for fleeing from police. It was named in honor of St. Louis County Detective Antonio Valentine who was killed in the line of duty. Detective Valentine was involved in a vehicle crash with a fleeing suspect while responding to assist fellow detectives.

Another provision included within the omnibus bill limits the authority of civilian review boards by reestablishing the authority of civilian boards as they were intended by state statute: to review and recommend. The Board of Alderman recently overstepped their authority establishing the new Civilian Oversight Board with broad authority over police. Then it was populated with anti-police activists who cannot possibly be fair and objective. This legislation thankfully puts an end to the authority of this board.

SLPOA Elections:

Petitions for candidacy for the open positions on the executive board were open from August 1st through August 7th per our By-Law and as announced on the SLPOA Website. All the even number divisions were available along with a one-year term in Division One due to the transfer of the current Division One Representative. In addition, the At-Large positions of Vice President, Recording Secretary and Treasurer were also open. Candidates were filed for all the open positions, aside from the Division One representative, but none of the races were contested. In cases such as this, the current Executive Board will certify the election at the September Executive Board meeting and the new members will be seated. Thank you to all the officers and sergeants who volunteered to serve on the board.

Golf Tournament:

The second annual SLPOA Golf Tournament presented by QuikTrip is fast approaching. We are still in need of Hole Sponsors and raffle prizes and there are a few spots left for golf teams. This year's tournament is being held at Stone Wolf Golf Club in Fairview Heights, Illinois. That course has since closed but now with one year of experience under our belt and with the backing from our friends at QuikTrip, we are looking forward to a bigger and better experience for our participants and hope to

Ferguson Officer Injured

The ten-year anniversary of Ferguson was marked with civil unrest resulting in a Ferguson Police Officer sustaining serious life-threatening injuries. As of this writing, Officer Travis Brown is still fighting for his life as his family, friends, coworkers and fellow officers from around the community rally around him, praying for his recovery. All of this could have and should have been avoided. This continued hostility and negative rhetoric toward law enforcement has severely altered the life of another member of our police family. The SLPOA Executive Board promptly donated to his family to help with immediate costs and a Go Fund me account has been established to support his family further. To donate please visit the Go Fund Me website and search for Support Ferguson Officer Travis Brown.

Another disheartening discovery from the violent protests was one of the people who was at the heart of all this unrest was a current member of the Civilian Oversight Board in the City of St. Louis. He was arrested and charged with felony Property Damage 1st Degree. His actions prompted a joint letter to Mayor Jones from SLPOA President, Jay Schroeder, Ethical Society of Police President, Donnell Walters, and St. Louis Police Leadership Organization President, Mickey Owens, calling for his immediate removal. SLPOA has since learned that the Mayor is unable to remove a member from the Civilian Oversight Board. Per Ordinance 71749, only the Civilian Oversight Board members can initiate such a removal, but this is only a request to the Board of Aldermen to take action and remove a member. Yet another reason why this haphazard system is flawed. SLPOA is aware that Alderman Tom Oldenburg, Bret Narayan and Laura Keys have been in contact with the Civilian Oversight Chairman demanding his removal. We appreciate their support!

Fortunately for law enforcement officers in the City of St. Louis, SLPOA saw the flaws with the ordinance enabling and empowering the COB and acted to restrict their authority through state statute in Jefferson City last year. Through our efforts, we were able to get language in statute that limits the overreach granted though ordinance and restores the authority of the COB to where it was intended by statute; to review and recommend. No more ability to conduct witch hunts on officers, subjecting them to unsubstantiated subpoenas and wasting the time of our already overworked police department by members of the community who continue to promulgate a false narrative about the events in Ferguson ten vears ago.

Mayor Jones,

As you already know, protests near the Ferguson Police Department turned violent this past weekend. Ferguson Police Officer Travis Brown was seriously injured when he was charged and knocked to the ground by a violent protestor. Officer Brown was required to undergo surgery on his brain, and he is still in critical condition. Additional officers sustained minor injuries while dealing with the violent protestors who decided to damage property, resist arrest and assault police officers.

It has come to our attention that one of the bad actors involved in the violent protest was Keith Rose, an active member of the Civilian Oversight Board. Mr. Rose was arrested and charged with a felony for Property Damage 1st Degree. Mr. Rose should be immediately removed from his position on the Civilian Oversight Board. We believe the actions of Mr. Rose demonstrate that he cannot uphold his duties to be fair and objective as required by the City's own Civilian Oversight Board member requirements. He has demonstrated a bias towards police officers and a disdain for the profession. Allowing him to continue in this role is an insult to the hard-working men and women of the St. Louis Police Department.

The leadership of the St. Louis Police Officers' Association, the Ethical Society of Police and the St. Louis Police Leadership Organization implore you to stand with your officers and remove Keith Rose from his post on the Civilian Oversight Board immediately.

This badge intentionally crashed into the wrong way driver on a highway to protect innocent motorists.


This badge helped find a lost child so his mother would stop crying hysterically.

This badge has been shot for simply existing.


This badge has been soaked in blood and tears.
